1. I realize the importance of the continued development of the kitten/cat and I agree to follow the breeder's instructions on the animal's care, housing, diet and health. This cat will always have prompt medical care and never be allowed to harbor parasites. I will provide adequate exercise for this cat and if caging is necessary, it will be minimal. This kitten/cat will never be allowed to roam freely out of doors. If this cat is found to be mistreated, neglected or inhumanely managed while in my care, I will surrender this cat & ownership papers, at my expense, to Nancy Duckett immediately and unconditionally without refund of the purchase price.
2. I am purchasing this kitten/cat for breeding and/or exhibiting. I understand the breeder offers no guarantees on future development, health, reproductive capabilities or show achievements on this kitten/cat. Should I become unable or unwilling to keep this kitten/cat I agree to notify Nancy Duckett via e-mail or telephone for first option to repurchase at ½ the purchase price. I will be responsible for the expenses involved in returning the kitten/cat to Nancy Duckett.
3. I will receive this kitten/cat with a current State of Florida Certificate of Veterinary Inspection indicating the animal is healthy and has all necessary immunizations, feline leukemia tested negative and is free from internal & external parasites.
4. I have the option to have this kitten/cat examined within 72 hours after purchase by a veterinarian of my choice. (It is strongly recommended the buyer isolate this kitten/cat from all other animals until the personal vet inspection has been completed.) If this kitten/cat is found by my veterinarian to be in ill health within this 72 hour period, I understand I can immediately notify Nancy Duckett, return the animal at my expense and receive full refund of the purchase price. There are NO REFUNDS given after the initial 72 hour period.
5. By signing this contract, I am in full agreement with all of the terms. In the event I violate this agreement, the damages of \$5000.00 US PLUS legal fees shall be payable to Nancy Duckett. Sole jurisdiction and venue for any legal dispute shall be in the State of Florida, County of Marion, U.S.A.
